I understand that the T&I and HSTE certification programs are open only to teachers who hold an initial Technical Specialist Certificate from the Georgia Professional Standards Commission. New Teacher Institute (NTI) attendance (summer) is permitted prior to admission into the Trade and Industrial and Healthcare Science Teacher Education programs. New Teacher Institute ends July 6.

July 9 is the deadline for submitting your application to the T&I and HSTE programs. I understand that I must submit a copy of my initial Technical Specialist Certificate **and** a passing score report from GACE Admission Assessment (or a copy of SAT, ACT, PRAXIS I or GRE scores verifying eligibility for exemption from GACE Program Admission Assessment).

Note: The passing score for each part of the GACE Program Admission Assessment is 250. There is no composite or combining all three tests. Each must be passed. Following are the eligible exemptions:

GACE Program Admission Assessment Exemptions:

- Having a Masters degree or higher from a PSC accepted accredited institution.
- Having passed all three parts of the Praxis 1 or posted a composite score of 526 before March 6, 2007.
- GRE – 1030 Verbal and Quantitative if test taken prior to August 1, 2011
297 Verbal and Quantitative if taken on or after August 1, 2011
- SAT – 1000 on Verbal and Math - for scores prior to 1995, click on the link below:
