**The Application for Re-entry is for inactive graduate students and/or for those out of compliance with Continuous Enrollment**

Any graduate student who falls out of compliance with the university's Continuous Enrollment Policy must submit an Application for Graduate Re-entry to the Office of Academic Assistance and Graduate Admissions. A student is subject to Re-entry if he or she meets any one of the following criteria:

- has not registered for courses at Georgia State during any of the previous three semesters, thereby becoming inactive;
- has not registered for six or more credit hours for the current and the two preceding terms as required by the university's Continuous Enrollment Policy;
- has been on scholastic suspension after an absence of one calendar year;
- has been on scholastic exclusions after an absence of five or more years.

The College of Education allows transient and non-degree graduate students to re-enter. Furthermore, students can only apply for Re-entry to their previous degree program and concentration. Entrance to another degree program requires the graduate application for admission. Re-entry applications must be approved by the degree program and may be denied because of a student's previous academic performance or progress in the program, or the length of time not enrolled.

Students who have attended other colleges and/or universities since last registering at Georgia State must have official transcripts of all coursework taken sent to the Office of Academic Assistance and Graduate Admissions, College of Education, prior to the reentry deadline for the appropriate semester.

Re-entering students are subject to the regulations of the Graduate Bulletin and the degree program current at the time of re-entry. Any special cases or exceptions to the Re-entry policy must be approved by the College of Education's Petitions Review Committee and require submission of a Student Petition for Waiver or Variance, available for download at [http://education.gsu.edu/oaa/docs/Petition\\_Waiver\\_Form.pdf](http://education.gsu.edu/oaa/docs/Petition_Waiver_Form.pdf).
